



## TENDER NOTICE REQUEST FOR PROPOSAL (RFP) FOR LAND DEVELOPMENT

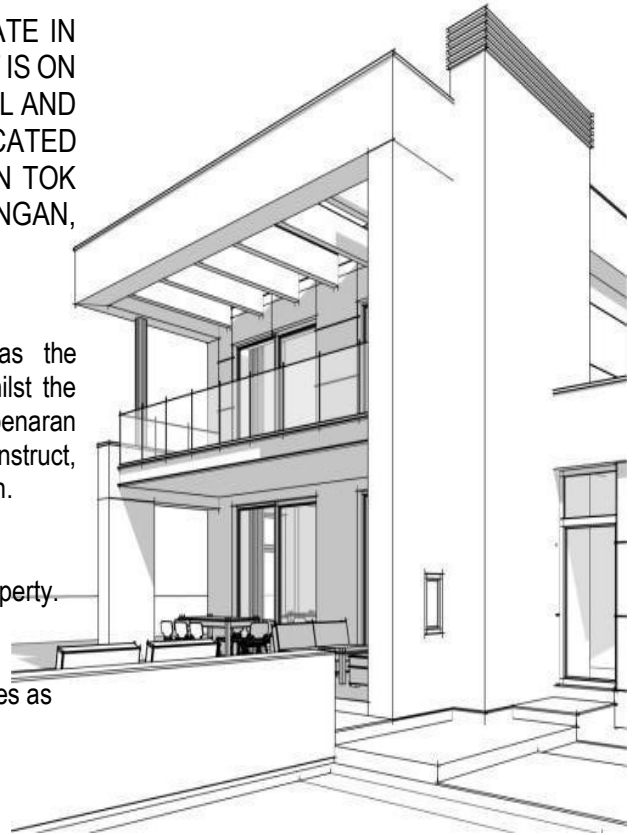
